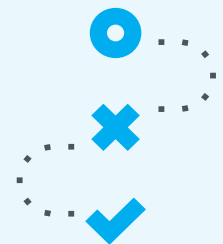
## PROTECTING CONFIDENTIAL INFORMATION IS KEY

## CASE STUDY: PFIZER REZULIN SETTLEMENT

**CHALLENGE:** In this mass action encompassing various Pfizer settlements concerning Rezulin, a diabetes drug linked to liver damage, GCG received, analyzed, and processed documents from over 200 law firms.

**RESOLUTION:** To accommodate the substantial number of documents and the constituencies interested in viewing the confidential information, GCG developed and maintained a secure website where each law firm could view all documentation for its claims, submit materials, and obtain claim statuses.
